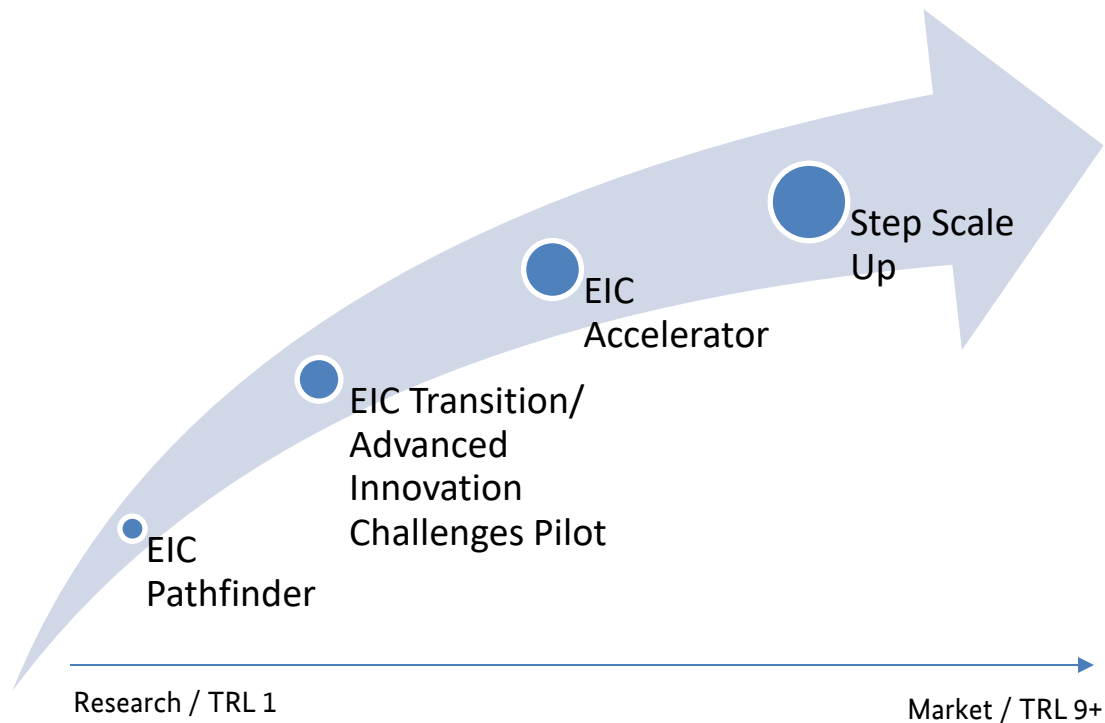

Pathfinder, Transition & AIC



EIC Pathfinder

- Funds research to develop the scientific basis to underpin breakthrough technologies
- Goal: Proof of principle (TRL 3)
- Low TRL: Start at TRL 1 or 2 and go for TRL 3 or 4.
- Open: Support of projects in any field of science
- Challenges: Support of coherent portfolios of projects within predefined thematic areas with the aim to achieve specific objectives

Deadlines:
Open: 12 May 2026
Chall.: 28 Oct. 2026
Budget per project:
up to €4 M

EIC Pathfinder Challenges 2026

1. Advanced Materials for Miniaturised Energy Harvesting Systems
2. Biotechnology for Healthy Ageing
3. DeepRAP: Deep Reasoning, Abstraction & Planning towards trustworthy Cognitive AI Systems

EIC Transition

Deadline:
16 September 2026

- Focus on results from EU funded projects
 - to mature the technologies
 - build a business case for specific applications
- Medium TRL: 3 / 4 - 5 / 6
- Grants of up to **€ 2.5 million to**
 - validate and demonstrate technology
 - develop market readiness



EIC Advanced Innovation Challenges

- High-risk, demand-driven deep tech innovations
- Involvement of commercial users (e.g. industry, public sector), end users and other key stakeholders such as regulatory authorities
- Medium TRL: 4 to 6 / 7
- Two-stage process:
 - 300.000 € for stage 1
 - 2,5 M€ for stage 2

Deadline: 26. Februar 2026

EIC Advanced Innovation Challenges - Topics

- TRL 4 at the start and TRL 6 or 7 at the end of the project.

Topics:

- Accelerating Physical AI: Embodied Intelligence for the Next Frontier of AI-Powered Robotics
- Translating Disruptive New Approach Methodologies (NAMs) into Practice

The EIC Pre-Accelerator



What is the EIC Pre-Accelerator?

Supporting early-stage deep-tech innovation in Europe

- The **EIC Pre-Accelerator** is an EU funding instrument under **Horizon Europe/WIDERA**, focused on early-stage deep-tech startups in **widening countries**.
- Helps SMEs develop **technology, business and investor readiness** before scaling or applying to larger instruments like the **EIC Accelerator**.
- Offers **grants up to ~€500 000**, coaching, mentoring and business acceleration services.




What Support is Offered?

- **Funding:**
 - Grants from **€300 000 to €500 000** per company for up to ~24 months.
- **Additional Support Services:**
 - Tailored **business acceleration services** (coaching, mentoring, networking).
 - Help in preparing for future EIC Accelerator applications.
- **Objective outcomes:**
 - Strengthened business and investor strategy.
 - Increased readiness to secure follow-on funding.

What are the funding criteria?

- ✓ **Country eligibility:** Widening countries of the EU + certain associated countries & outermost regions.
- ✓ **Applicant:** Single SME or startup legally established in eligible country.
- ✓ **Technology readiness:** TRL ~4+ (validated in lab or prototype stage).
- ✓ **Submission:** Through the **Funding & Tenders Portal**.

Timeline

-  **2025 Call (pilot)**
 - **Call opening:** 12 June 2025.
 - **Submission deadline: 18 November 2025.**
-  **Post-submission timeline:**
 - Evaluation expected to conclude by **Feb 2026**, results communicated in **late Feb – early March 2026**.
-  **Next call:**
 - Announced to open around **May 2027** (subject to official Work Programme publication).

- Cutting-edge scientific advances and discoveries,
- need to stay at the technological forefront by constant interaction with new ideas and results from the lab,
- potential to deliver transformative solutions, rooted in cutting-edge science, technology and engineering, including innovation that combines advances in the physical, biological and digital spheres,
- Distinct from 'high tech' which tends to refer only to R&D intensity.

Deep tech ventures

- positioning at the knowledge frontier with long and uncertain R&I cycles;
- relates to tangible products and industrialization processes;
- linked to the ecosystem and especially higher education institutions, problem oriented, or mission driven, focused on the creation of an option space and a dynamic de-risking cycle.

What will be financed?

Grant up to €2.5 million Euro (70%)

Funding rate)

Innovation activities:

Development , demonstration and prototyping,
approval, IP, preparatory market launch

Investment of 1 – 10 million. Euro :

Financing the market launch and Scale-up



Grant/ *Grant*

- Basically, innovation and market launch activities (development, demonstration activities, prototyping , testing for standardization, IPR, market approvals) from TRL 6 - TRL 8
- up to €2.5 million , 70% funding rate
- Lump sum

Investment component

- Investment guidelines lay the foundation
- A matter for negotiation between the EIC fund and the company
- Co-investor (50%) required – ideally a letter of intent is already in place for the application.
- EICF share between 10–25% of voting rights
- Exit after 7–10 years (longer, e.g., in case of health issues)

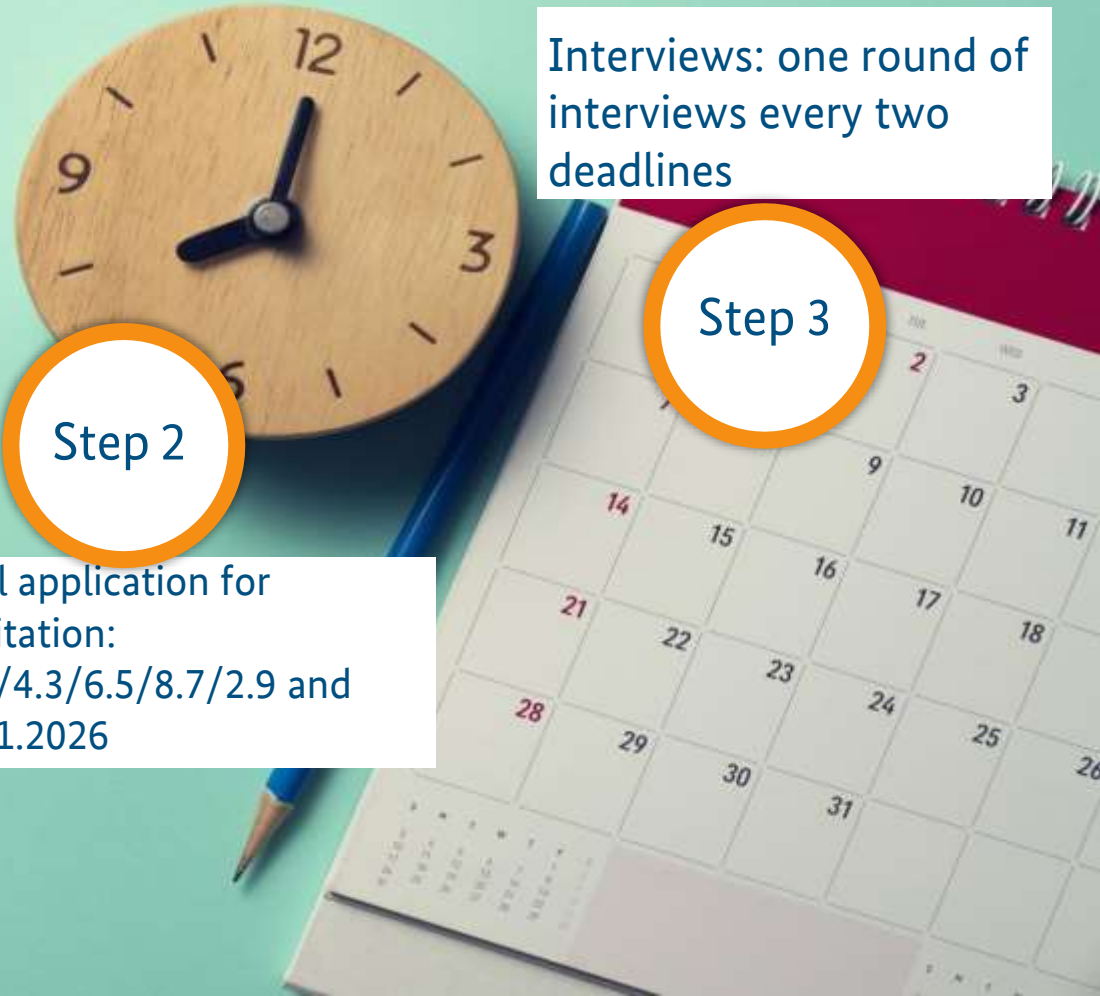

EIC Accelerator Overview: Innovations 2026

- Minimum investment: EUR 1 million
- Six deadlines for the full application – three rounds of interviews
- New templates for short application and full application
- New evaluation process for the full application

New features 2026

Template Short Application

- Reduced number and more focused questions (6 instead of 11).
- A more objective and evidence-based presentation.
- No questions regarding the company's mission/vision, problems and opportunities, or impact (full application).
- New: IP strategy in the short application (no FTO).
- The application forms (Part B) and the assessment questions are fully coordinated.

New features 2026

Template Full application

- Max. 20 pages (previously 50).
- However: Implementation plan in the appendix
- No DMP, CV and usually no Ownership Control Declaration

Evaluation Full Application

Evaluation steps:

- Tech Expert
- Interview with Tech Expert
- Remote Panel
- Panel Meeting → Points and Ranking for Interview Invitation

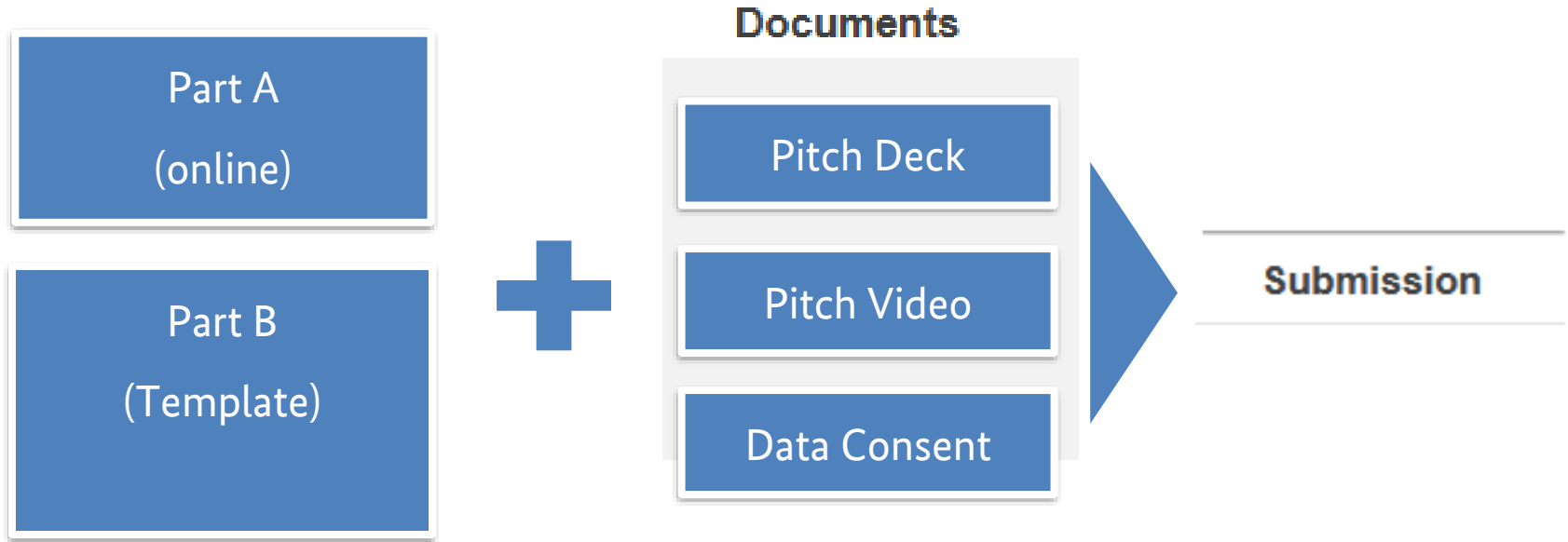
